Safe error-free medication ordering and distribution.

The eMAR interface provides resident pictures for identifying the right resident, and color coding allows staff to determine when the right medication is due at the right time.

Ensure closed-loop medication ordering and distribution.

PointClickCare eMAR is a full medication and treatment administration system that is securely accessed online for real-time accuracy and dependability, with the optional ability to integrate directly with pharmacy partners.

Whether accessing the eMAR from within the web application or on a mobile device, providers benefit from safe, error-free medication ordering and distribution, improved compliance, and significant time-savings for care team members. With mobile access to real-time clinical information, care team members are able to make better, more informed care decisions while in close proximity to the resident.

Safely order and distribute medication.

PointClickCare eMAR ensures that the "Rights" of medication safety are upheld. Leveraging computerized physician order entry, a centralized EHR, and displaying only the medications of specific med passes, it manages the entire ordering and distribution process to ensure that the right resident, is receiving the right medication, in the right dose, using the right route, at the right time.



Ensure medication compliance.

Strict regulations demand accurate and complete documentation of resident and medication information, and govern pharmacy-dispensing compliance. The eMAR module promotes adherence to documentation policies, while providing the security necessary to handle sensitive personal health information between communities and pharmacies.

With automatic PRN and vitals reminders, providers will be able to significantly decrease the occurrence of missed or late medications. Resident status, including discharges and transfers, are automatically communicated to the pharmacy to prevent the receipt of medications in error. eMAR also supports the Drug Enforcement Agency (DEA) regulations for ePrescribing of Controlled Substances (EPCS).

Reduce time constraints on caregivers.

PointClickCare eMAR allows care staff to efficiently order and distribute medications, eliminating cumbersome MAR/TAR binders. The always up-to-date eMAR allows staff to dispose of month-end change over activities, and automatically pushes pertinent resident information to PointClickCare’s EHR.
