

Executive Summary – Impacts to Wellness and Safety



There was a 200% increase in polypharmacy over 20 years

Impact

Seniors are hospitalized due to serious side effects from one or more medications. Unnecessary hospitalizations generate billions of dollars in costs.



50% Staff Turnover in Senior Living

Impact

Staffing shortages cause many problems, such as decreased caregiver availability to residents, reduced care continuity, and decreases in revenue. Staffing challenges are expected to get worse, especially as baby boomers retire.



Between 2020 and 2030 the number of older adults is projected to increase by almost 18 million

Impact

2030 marks the year when all baby boomers will be older than 65, comprising 20% of the population, and more seniors will need more care. Seven out of 10 people will require assisted living care in their lifetime. The aging population, especially those over 85 years, often suffer from complex health conditions. Nearly 95% of older adults have at least one chronic condition, and nearly 80% have multiple chronic conditions.



Older adults (65 years or older) visit emergency departments more than 600,000 times each year, more than twice as often as younger persons

Impact

One of the most common reasons for hospital visits among older adults is due to preventable medication errors. A primary cause is communication breakdowns between the prescribing provider, pharmacy, and wellness team. The need for better communication and information between the various care team members will continue to grow.




Types of Pharmacies Used by Current Residents

Senior living residents use multiple types of pharmacies. Long-term care (LTC) pharmacies had the highest percentage of use, followed by mail order pharmacies, and then commercial retail pharmacies.

Pharmacy Used Most Consistently by Current Residents


Many senior living communities offer the services of LTC/Institutional pharmacies to provide a better experience for their residents. These pharmacies offer delivery services, technology, and advanced packaging. LTC pharmacies are more commonly used by residents than other types of pharmacies.

The majority of senior living residents have seen value in participating in the service offering of senior living communities that partner with an LTC pharmacy to fill their required prescriptions.


What Percentage of Residents Use The Following Most Consistently?



How the Community Manages Resident Prescription Orders

The majority of communities still do part of their prescription orders manually using a combination of paper, fax, and phone calls and another large majority indicate that prescribers communicate directly with pharmacy. Almost half are using an automated approach through integration directly with the pharmacy.



Roles Dispensing Medications to Residents

The vast majority of roles dispensing medications are medication technicians or medication care partners, with a strong presence of Licensed Practical Nurses (LPNs) as well. It is becoming more prevalent that medication technicians are the responsible team member for dispensing medications to residents.

Primary Challenges of Medication Management

Many respondents cited a general communication failure between the prescribing practitioner, pharmacy, and medication technician passing the medication to residents.

- Communication between pharmacy and other parties involved
- Converting all residents to a single pharmacy





Medication Order Management Challenges for Senior Living Communities Lacking Direct Integration With an Institutional Pharmacy

Survey respondents who are not currently integrating with a long-term care pharmacy partner indicated the various challenges associated with integrated medication order management. Fifty percent or more of the respondents rated the following benefits as being "challenging".

% of Respondents Indicating Challenges






Conclusion
